ELIGIBILITY: Teams must comprise of an eligible MP, Class A (excluding A-3's), B-1 or B-4 **AND** an A-8, eligible assistant or registered apprentice from the same facility. Participants must be eligible as prescribed by the Carolinas PGA Tournament Rules and Regulations prior to the date entries close. If there is a question regarding eligibility, please contact the CPGA office. Please note that an A-6 is **NOT** an assistant.

ENTRY FEE: \$410.00/TEAM. Entry fee includes carts, range balls, tee gifts, contestant lunch each day of the tournament, and a players' reception prior to the first round.

ENTRIES CLOSE: Entry applications must reach the CPGA Headquarters by 5:00 p.m. on Thursday, June 19. The field is limited to the first 112 eligible teams. **If the number of entries exceed 112, the CPGA priority system will be in effect.** Applications late or incomplete are not acceptable. Faxed entries with a valid credit card number will be accepted. The CPGA fax number is (843) 399-1504. Telephone entries will not be accepted. **Teams may register online at www.carolinas.pga.com as well.**

FORMAT: 36-HOLE, FOUR-BALL STROKE PLAY (better ball of the pair). Each team will play one round at each course. There is no cut. A tie for the Championship will be settled by a sudden-death playoff beginning at a hole to be determined at the Members Club at Grande Dunes.

PRACTICE: The official practice round is Sunday, June 29 at the Dunes Club only. Practice round starting times are limited and are on a space available basis. There are no practice rounds available at the Members Club.

STARTING TIMES: Starting times and contestant information will be available on Friday, July 20 at www.carolinas.pga.com. No refunds will be granted after 5:00 p.m. on Saturday, June 28. Any applicable refunds will be made upon completion of the tournament.

RULES: Play will be governed by the 2007-2008 USGA Rules of Golf and the CPGA Tournament Rules & Regulations. Questions shall be settled by the designated Rules Committee; whose decision shall be final.

CADDIES: Caddies are permitted. Refer to the CPGA Tournament Rules & Regulations for caddie guidelines.

REGISTRATION: There will be a players' reception on Sunday evening, June 29 at The OCEAN CLUB at Grande Dunes (On the ocean at 82nd Ave North, next to the Marriott, NOT AT THE COURSE). Final details and directions will be included with the starting times. Titleist and Foot-Joy representatives will be distributing contestant gifts at this time as well.

PUTTING CONTEST: TITLEIST/FOOT-JOY/COBRA WORLDWIDE will host a putting competition during the first round at the Members Club at Grande Dunes.
