**ELIGIBILITY:**

This tournament is open to male amateurs who since January 1, 2014 have been bona fide public course players and have not held privileges of any course which does not extend playing privileges to the public. The player must also be a resident of Maryland and/or hold an active handicap at a member club of the MSGA which is not a strictly private club. Entrant must have an up-to-date USGA Index of 5.4 or less at a licensed club as of May 15. The Handicap Index must be current on the date of the event and must be viewable on the verification site of [www.msga.org](http://www.msga.org). Applicant acknowledges having read and understood the "Interpretation of Eligibility Rule" which appears on the MSGA web site: [www.msga.org](http://www.msga.org). Entries are subject to rejection by the MSGA at any time, including during the competition. The reason for rejection may include unbecoming conduct, such as violation of host club policies, or failure to comply with the requirements of the handicap system.

**COMPETITION:**

The tournament will be conducted at 36 holes stroke play.

**ENTRIES:**

Entries open on Wednesday, May 28 and a properly completed entry form and fee of **\$160.00** must be received at the MSGA office by 4:00 PM on Thursday, July 3. The field will be limited to the first 78 entries received on a timely basis.

Additional players will be placed on a waiting list. The entry fee includes cart and range balls. Starting times will be emailed and can be obtained on or after July 11 by viewing [www.msga.org](http://www.msga.org). Automotive transportation and pull carts are permitted.

**REFUND POLICY:**

A withdrawal prior to seven days of the event will receive a refund minus a \$25.00 processing fee. There will not be a refund if a withdrawal is received less than seven days prior to the event without written medical excuse.

**PRIZES:**

Appropriate prizes will be awarded to the winner and other top finishers. In the event of a tie for the Championship, there will be a hole-by-hole play-off at the conclusion of play.

**RULES:**

The player is responsible for being familiar with *Local Rules and Conditions of Competition for MSGA Championships and General Conditions and Regulations for MSGA Men's Events*, both of which appear on [www.msga.org](http://www.msga.org).

**In this competition, the local rule outlined in Appendix I permitting the use of distance-measuring devices that measure distance only is applicable. The 2010 Groove and Punch Mark Condition is NOT in effect.**
