Seniors & Super-Seniors: JUNE 25-26, 2012 (Monday-Tuesday)

FORMAT: 36-holes of stroke play for Senior & Super-Senior players. The field will be comprised of the LOWEST 120 WSGA/USGA Handicap Indexes from both fields combined. Current officers are exempt.

RULES: USGA rules. Each player should have a current rulebook.

ELIGIBILITY: The tournament is open to all amateur senior women (50+ by June 25, 2012) and super senior women (62+ by June 25, 2012), who are legal residents of Wisconsin and a member in good standing of a WWPLGA member club or have a WWPLGA individual membership. NOTE: Please make sure your club has paid dues. If not, you must send \$35 - Club Membership or \$15 individual membership to: (See website - www.wwplga.org)

Nonresident members must agree to not participate in any other state's major tournament - Signature required below. All entrants must have a current WSGA/USGA handicap index. IF YOU HAVE TWO (2) WSGA INDEXES, THE LOWER OF THE TWO WILL BE USED.

ENTRY FEE & DEADLINES: The entry fee for seniors & super-seniors is \$150.00 with cart and unlimited range balls and includes Tuesday's contestant lunch at the end of play. Make checks payable to the WWPLGA SENIOR/SUPER-SENIOR CHAMPIONSHIP and send to: Aimee Linneman c/o WSGA 11350 W. Theo Trecker Way West Allis, WI 53214. Entries are due to Aimee by June 8, 2012. No refunds will be made after one week prior to the tournament start. Emergency withdrawals will be handled by the tournament chair. She will determine a refund based on a monetary commitment to the course & to the prizes. . PLEASE ENCLOSE A SEPARATE CHECK FOR EACH TOURNAMENT ENTRY BLANK SUBMITTED TO THE WWPLGA. OR, PROVIDE CREDIT CARD NUMBER, TYPE AND EXPIRATION DATE, THEREBY AUTHORIZING THE WWPLGA TO CHARGE THE CARDHOLDERS ACCOUNT FOR THE AMOUNT OF ENTRY FEE (\$150.00). CARTS: Carts are mandatory. Caddies and walking will NOT be permitted.

PAIRINGS: Pairings will available online and EMAILED to all players on JUNE 11, 2012. Pairings and flighting will be done by considering the size of the field, and indexes. Players will be re-paired in their flight for the 2^{nd} round based on 1^{st} round scores.

TEAM TROPHY: The team trophy will be awarded to the club whose team of ANY FOUR golfers has the LOWEST NET TOTAL after the first round. Ties shall be broken by using 36-hole scores if necessary. There will be a team event in both divisions, senior and super-senior. You will designate the team vou are playing with on the entry form.

PRIZES: Prizes will be awarded based on the number in each flight. Ties for first place only will be broken by a sudden-win play-off. Others ties shall be determined by a scorecard playoff in reverse order. Prizes will be awarded for low gross scores in the senior division and low gross & net scores in the super-senior division. The champion for each division is the lowest 36 hole score regardless of flight.

DRESS CODE: Unsuitable dress is defined as very short shorts, bra or halter-tops or strapless tops. **NO METAL SPIKES ALLOWED.**

ELECTRONIC DEVICES: Distance measuring devices that measure distance only will be permitted. Cell phones NOT allowed on the course unless emergency arrangements are made with the tournament chair. No other electronic devices allowed.

PRACTICE ROUNDS: Practice rounds are available at any time for \$35.00 with cart. Identify yourself as a Senior/Super-Senior participant.

START TIME: 8:00am SHOTGUN start on both days. All players must register between 7:00 - 7:30 AM both mornings. Be ready to go to your designated tee no later that 7:45 am or you will be disqualified.
