ILLINOIS PGA JUNIOR TOUR TOURNAMENT WAIVER

ILLINOIS PGA JUNIOR TOUR RULES OF CONDUCT PLEDGE, LIABILITY AND MEDICAL RELEASE

I agree to adhere to the current United States Golf Association Rules of Golf© and etiquette of golf described therein. I will conduct myself in a courteous manner and in accordance with the ILLINOIS PGA JUNIOR TOUR Rules of Conduct and PGA OF AMERICA Code of Ethics while on the property of the host venue. I also agree to follow all of the policies set forth by both the host facility and the ILLINOIS PGA JUNIOR TOUR.

I, hereby release the ILLINOIS PGA JUNIOR TOUR, its members, supporting organizations, directors, staff agents, escorts, site owners/hosts, successors and assignees from all liability, claims, or other forms of legal action, including costs arising there from, against any incident which results in or arises out of any loss, property or personal (death included), which may be sustained by the junior player member or parent/guardian during travel to, from, or participation in, any ILLINOIS PGA JUNIOR TOUR event or activity.

Participants release the ILLINOIS PGA JUNIOR TOUR and the Illinois PGA Section, it's Officers, Directors, Members, employees, successors and assigns (the "Indemnified Parties") from any and all claims for loss and damage, inclusive of, but not limited to personal injury, whether or not caused by participant's use of spikeless/non-metal golf shoes at the event premises in connection with the tournament. The consideration for this release is the permission granted by the Section to the participant to participate in the golf tournament. This release binds not only the participant, but also the participant's spouse, heirs and legal representatives.

I understand that I am agreeing to the use of my name and/or likeness for ILLINOIS PGA JUNIOR TOUR and Illinois PGA publicity and promotional purposes under PGA of AMERICA and USGA guidelines.

In case of an emergency during an ILLINOIS PGA JUNIOR TOUR event, I grant my authorization and consent for general first aid treatment for any minor injuries or illnesses experienced. If the injury or illness is life threatening or in need of emergency treatment, I authorize ILLINOIS PGA JUNIOR TOUR and/or event host site staff and/or volunteers to summon any and all professional emergency personnel to attend, transport, and treat me. It is understood that this authorization is given in advance of any such medical treatment, but is given to provide authority and power on the part of the ILLINOIS PGA JUNIOR TOUR and/or host site staff and/or volunteers the exercise of his or her best judgment upon the advice of any such medical or emergency personnel.

All entry fees are non-refundable after the entry deadline, except for family emergencies, family death or medical emergencies. All refund requests due to medical emergencies must be accompanied by documentation from a physician alongside the ILLINOIS PGA JUNIOR TOUR Refund Request Form listed online.

By registering for an event, both the registrant, and/or the parents/legal guardians of that registrant acknowledge that he/she has read and understand the information stated above.
