Play is governed by the Rules of Golf, the 2024 NTPGA Junior Tour Rules & Regulations, the 2024 All American Tour Rules of Play Card, and the following Supplementary Rules of Play which applies to this golf course. Note: Disregard any local rules found on the club's scorecard and any signs posted for member play.

NOTICE TO PLAYERS

RE-PAIR: The Tierra Verde Classic will be contested at individual stroke play over 36-holes. Players will be re-paired for the Final Round within the Girls 13-18 and 12 & Under divisions and the Boys 13-14, 15-18 and 12 & Under divisions according to their score for Round 1. Lower scores in each division will tee off late and higher scores will tee off early within their respective division.

FORMAT: Four (4), 9-hole rounds played over two days (18 holes each day). If all 36 holes are not completed by a division due to weather, frost, lack of daylight or the like, scores will revert back to 27 holes. If 27 holes have not been completed, scores will revert back to 18 holes. If less than 18 holes have been completed, the tournament will be canceled. Each division will act independently when determining how many holes will count in the respective division. NOTE: if a division is reduced to 27 holes, the entire division would need to have played the same holes, if not, the event would revert back to 18 holes.

TEE MARKERS: Boys 15-18: AAT Silver | Boys 13-14: AAT Gold | Boys 12 & Under: AAT Green | Girls 13-18: AAT Blue | Girls 12 & Under: AAT Red

NINE-STROKE LIMIT: The nine-stroke limit will **NOT** be in effect.

PACE OF PLAY: 4 hours and 52 minutes.

PENALTY AREAS: Penalty areas are identified by red or yellow penalty area stakes. **The penalty areas are defined by the course-side edge of the native/unmaintained areas.** The mow line of these areas can be used to help identify the edge.

DROP ZONE (Hole #14): There will be a drop zone on hole #14 located on the forward tee. Players may use the drop zone or take relief under yellow penalty area relief (Rule 17.1d). NOTE: Lateral relief from a yellow penalty area is **NOT** permitted.

OUT OF BOUNDS: Defined by white stakes and where white stakes tie into property perimeter fencing and the inside edge of the curbing of all public roads and the parking lot. **Out of bounds is also defined by the property fence left of #5, behind #6 green and left of #7.** NOTE: The new Alternative to Stroke and Distance for Lost Ball or Ball Out of Bounds (model local rule E-5) in the 2023 Rules of Golf is NOT in effect on the All-American Tour. Any player that has a lost ball or ball out of bounds **MUST** use stroke and distance for their subsequent shot.

GROUND UNDER REPAIR: All ground under repair in the General Area is identified by white lines. Relief will be granted for the lie of the ball, the player's stance, and the player's area of intended swing. The construction area left of the green on hole #11 is ground under repair. Players may take relief under Ground Under Repair (Rule 16.1).

IMMOVABLE OBSTRUCTIONS (IO): The fence behind #18 tee box and any pumphouses or restrooms will all be played as immovable obstructions. Relief is granted only for stance and swing, NOT line of play.

TEMPORARY IMMOVABLE OBSTRUCTIONS (TIO): Black tarps and additional equipment (wood pallets and rebar) used to cover the putting greens are temporary immovable obstructions. Also included are tents and championship signage. Free relief may be taken for a player's line of play, lie of ball, stance and swing. NOTE: The championship hole signs for #1 and #10 are also temporary immovable obstructions.

PLAYING TWO BALLS: A player who is uncertain about the right procedure while playing a hole may complete the hole with two balls without penalty. The player should choose which ball will count by announcing that choice to another player or marker before making a stroke, and if the player fails to do so, the ball played first is treated as the ball chosen by default. The player **MUST** report the facts of the situation to the Committee before turning in their scorecard, and if the player fails to do so, they will be disqualified. (Rule 20.1c(3)).

RED PENALTY AREA WITH AN OPPOSITE SIDE RELIEF OPTION: None. See item 2(b) on the 2024 All American Tour Local Rules and Conditions of the Competition.

SCORING AREA / SCORECARDS: The scoring area is located **near the back patio** and is defined by a **yellow line**. Immediately upon completion of the round, players are required to go directly to the scoring area. All players are responsible for verifying that their hole-by-hole score is correct on the paper scorecard.

TIES FOR CHAMPIONSHIP: Ties for first place in each division and the overall champion will be broken using a hole-by-hole playoff. If a player is not present to compete in the playoff, he/she will be deemed to have forfeited the playoff. Should weather or darkness interfere, a scorecard playoff will be utilized beginning with the Final Round scorecard.
