



2024 WPGA CUP

Conditions of Eligibility, Selection and Qualification

Eligibility

Those eligible to represent Great Britain & Ireland ("GB&I") in the Women's PGA ("WPGA") Cup must be Members in good standing with the WPGA. They must have qualified as PGA Professionals through the training programme, be working within the industry and cannot be full time tour professionals.

The WPGA Cup is open to the following:

- All WPGA Members (Excluding Class I and Trainees)

Selection and qualification

The 2024 GB&I Women's PGA Cup Team of 5 WPGA Members will comprise of:-

- a) Top 2 from the combined 2023/2024 WPGA Championship points list.
- b) Top 2 from the combined 2023/2024 OceanTee WPGA Series points list not already qualified.
- c) One Captain's Pick (1 place).

The 2023/2024 WPGA Championship points list

The combined points list will be formulated from the results of the WPGA Championship in 2023 & 2024. The points breakdown will be as follows:-

Ineligible players

In the event of an ineligible player (e.g. a trainee) finishing in the top 10 of the WPGA Professional Championship, her points are disregarded for the purposes of WPGA Cup qualification and are **not** redistributed to eligible players.

Ties for the second qualifying place

In the event of a tie for the last qualifying place on the 2023/2024 WPGA Championship Points List, a 'hole-by-hole' play-off will be held at the 2024 WPGA Championship to determine the second qualifying player for the WPGA Cup team.



2024 WPGA CUP Conditions of Eligibility, Selection and Qualification

The 2023/2024 OceanTee WPGA Series points list

The combined points list will be accumulated from the 2023 and 2024 OceanTee WPGA Series events as follows:-

- The best 5 points finishes in 2023; and
- the 5 best points finishes in 2024.

In addition to the points breakdown for the WPGA Championship detailed above, the following points allocations will apply:-

For WPGA one day pro-only tournaments:

Ineligible players

In the event of an ineligible player (e.g. a trainee) finishing in the top 10, her points are disregarded for the purposes of WPGA Cup qualification and are **not** redistributed to eligible players.

Players already qualified

Those players already qualified for the 2024 WPGA Cup Team through the 2023/2024 WPGA Championship points list shall be removed from the 2023/2024 OceanTee WPGA Series Points List at the time of qualification and any points they had already accumulated on the 2023/2024 OceanTee WPGA Series Points List shall **not** be redistributed. Should a qualified player finish in the top 10 in subsequent WPGA Series events, her points are disregarded for the purposes of WPGA Cup qualification and are **not** redistributed to eligible players not already qualified.

Ties for the last qualifying place

In the event of a tie for the last qualifying place on the 2023/2024 OceanTee WPGA Series points list, players will be split by the most number of wins in the 2024 WPGA Series and, if still tied, the most number of second place finishes, third place finishes and so on until the fourth qualifying player for the WPGA Cup team is identified.



2024 WPGA CUP

Conditions of Eligibility, Selection and Qualification

Captains Pick

The Captain, with the agreement of the WPGA Committee, will select one eligible player of her choice as the final member of the WPGA Cup team.

In the event of a player being unable to compete or withdrawing from the 2024 WPGA Cup team for any reason, including ineligibility **following the conclusion** of the 2024 OceanTee WPGA Series Order of Merit, the WPGA Committee will replace that player with an eligible player of their choice. Such a withdrawal must be made in writing to the WPGA Secretary and is not reversible.
