FORMAT

Competition will be match play. All players will be flighted after an 18-hole stroke play qualifying round on June 13, 2011. All matches will be 18 holes. All players will play a minimum of two matches. There is a consolation division in all flights.

ELIGIBILITY

Entry is open to all junior amateur female golfers. Juniors are defined as: under age 18 on the first day of the tournament, or age 18 and a current-year high school graduate who has not yet competed on a college golf team. Entrants must have a WSGA HANDICAP INDEX OF 36.4 or less. **NO HANDICAPS FROM OTHER STATES WILL COUNT TOWARDS YOUR ELIGIBILITY.** Handicap Index as of **June 1, 2011** will be your official Handicap Index for this tournament.

ENTRY FEE

The entry fee of **\$85.00** must accompany the entry blank. Make checks payable to the WWSGA JUNIOR MATCH PLAY CHAMPIONSHIP and send with the entry blank after **May 1, 2011. Entries received before May 1, 2011 will not be processed until May 1. PLEASE ENCLOSE A SEPARATE CHECK FOR EACH TOURNAMENT ENTRY BLANK SUBMITTED TO THE WWSGA. OR, PROVIDE CREDIT CARD NUMBER, TYPE AND EXPIRATION DATE, THEREBY AUTHORIZING THE WWSGA TO CHARGE THE CARDHOLDERS ACCOUNT FOR THE AMOUNT OF ENTRY FEE (\$150.00). DEADLINE

The lowest 24 handicap entries received by **May 25, 2011** will compete in the tournament. Late or incomplete entries are not acceptable. **No refunds will be made after June 1, 2011.** No refunds provided if the WWSGA event is cancelled due to inclement weather or circumstances beyond our control. Entry fee will be fully refunded if the WWSGA (414) 443-3560 is notified before the close of entries. After the close, entry fee will be refunded only if the field is full and the spot can be filled if requested and approved prior to the start of the tournament. A \$20.00 service charge will be deducted from all refunds requested and granted after the closing date of entries.

DRESS CODE

Appropriate golf attire must be worn during play. The WWSGA interprets appropriate attire to include at least **mid-thigh length shorts** and skirts, slacks but no jeans and no "T" shirts or halter-tops. The Committee is the determining factor as far as appropriate attire is concerned.

PRACTICE

There will be no official practice round.

PAIRINGS

Players will be notified of their starting times and pairings. Pairings will be mailed on **June 1, 2011** or EMAILED on May 31st for those with an email address on file.

CADDIES AND GOLF CARS

Juniors must walk and carry. No caddies or golf cars are permitted.

PRIZES

A trophy and medal will be awarded to the Junior Champion. WWSGA medals will be awarded to all flight winners.
